1. Mrs. B. Sujatha, Malumichampatty has filed an appeal petition before the Electricity Ombudsman as the licensee has not changed the tariff of her SC No.1199,1232,1234,1521,1523 & 1524 from tariff V to tariff IA as ordered by the CGRF of Coimbatore Electricity Distribution Circle / South. The above appeal petition dated 25.7.2012 was registered as appeal petition No. 31 of 2012.

2. Accordingly, a copy of the petition was forwarded to the Superintending Engineer/Coimbatore EDC/South for filing a counter. A hearing was also scheduled at the office of the Electricity Ombudsman on 11.9.2012.

3. Meanwhile the appellant Mrs. B. Sujatha, in her letter dt.28.8.2012 has intimated that the Assistant Executive Engineer has agreed to change the tariff back to domestic tariff IA from V and hence she is withdrawing her appeal petition.

4. The Superintending Engineer/Coimbatore EDC/South in his letter dt.30.8.2012 has intimated that the tariff has been changed from V to IA by the field officials on 28.8.2012 as per the orders of CGRF dt.2.3.2012 and hence the appellant has withdrawn the Appeal Petition No. 31 of 2012. The Superintending Engineer/Coimbatore EDC/South has also enclosed a copy of the withdrawal letter received from Mrs. B. Sujatha for reference.

5. As the appellant has withdrawn the Appeal Petition, the A.P. No.31 of 2012 is dismissed as withdrawn.
